<p style="text-align: center;"><u>Target audience</u></p> <p>Participants should be top senior managers/members (equivalent to brigadier/general or equivalent ranks, State secretaries or equivalent, political and security directors etc.) from defence, security, police, diplomacy and industry from all EU Member States and from the EU Institutions: those that will make decisions on and implement strategy. In addition, selected academics will be invited and their work will contribute to the substance and to the image of EU strategy.</p> <p>Course participants must be available for the whole course, which includes eLearning phases and residential modules, and must be ready to contribute with their specific expertise and experience throughout the course. Participants have to be security cleared to at least EU CONFIDENTIAL level.</p>	<p style="text-align: center;"><u>Aim</u></p> <p>The overall aim of the CSDP Top Level Strategic Course (TLSC) is to generate, stimulate and enhance a professional environment of exchange ideas and to transmit a senior level of knowledge, facilitating networking and critic approaches in selected topics. While the focus is more one on the comments and elaboration of strategic concepts than on classic presentations and q&a sessions, the course itself generates the environment meant to promote a common European security culture and aims to foster the network of current leaders involved in the strategic aspects of the CFSP/CSDP (the course is not intended to prepare the participants for a senior position). Throughout the intended audience, the course facilitates formal and informal interventions at a top management level and benefits from the positive experience deriving from their unique vision in a blended approach.</p>

Evaluation and verification of learning outcomes

The course is evaluated according to the Kirkpatrick model: it makes use of *level 1 evaluation (based on participants' satisfaction with the course)* and *level 3 evaluation (assessment of participants' long-term change in behaviour after the end of the course)*. *Evaluation feed-back* is given in the level 1 evaluation on the residential modules.

In order to complete the course, participants have to accomplish all learning objectives, which are evaluated based on their active contribution to the residential modules, including their syndicate sessions and practical activities as well as on their completion of the eLearning phases: course participants must finalise the autonomous knowledge units (AKUs) and pass the tests (*mandatory*), scoring at least 80% in the incorporated out-test/quiz. **However, no formal verification of learning outcome is foreseen; proposed ECTS is based on participants' workload only.**

The Executive Academic Board takes these factors into account when considering the award of *Certificates* to participants. Module leaders provide an evaluation report for each residential module. The Course Director is responsible for overall coordination, with the support of the ESDC Secretariat, and drafts the *final evaluation report* which is presented to the Executive Academic Board.

Main topic and contents

The course encompasses three residential modules – each of them lasts 3 to 4 days. , each of which lasts one week and will focus on specific strategic aspects of the CSDP. All residential modules are preceded by a mandatory eLearning phase which provides course participants with the necessary theoretical background to actively participate in the residential phase. The time between the residential modules should allow a proper learning process using the eLearning platform ILIAS: all course participants have to prepare for each residential module by completing the relevant eLearning module.

<u>Aim</u>			
<p>The aim of the 1st module of the CSDP Top Level Strategic Course is to provide a superior overview of the CFSP/CSDP and related EU policies and concepts. It offers an opportunity to all course participants to attain a similar level of knowledge and understanding of the EU and the main subjects of the CFSP/CSDP, how the EU institutions work and the role they play in the CFSP/CSDP.</p> <p>The module focuses on the CSDP in the overall context of the CFSP. It will cover, inter alia, the relevant articles in the TEU, the EU Global Strategy and subsequent Council conclusions on its implementation, EU policy shaping, decision-making and inter-institutional cooperation in general. The module is designed to deepen understanding of how the EU institutions work and interact and what role they play in the CFSP/CSDP, to provide an insight into recent EU strategic-level documents and policies and to broaden understanding of EU decision-making processes at political/strategic level and external action. It familiarises participants with the EU institutions, the EEAS and relevant EU agencies as well as other organisations/structures located in Brussels.</p>

<u>Aim</u>
The 2 nd module of the TLSC focuses on the rationale and challenges of the development of military and civilian crisis management capabilities. The module is designed to discuss as an interactive brainstorming the EU crisis management concepts, processes and tools, to update and create broaden understanding of crisis management capabilities amongst participating decision makers. In addition, develop ideas to create synergies between civilian and military capabilities, discuss the implementation of the Civilian CSDP Compact as well as issues relating to European armament cooperation and procurement. It offers an opportunity to enhance understanding of major programmes conducted by the EDA. The module also provides an insight into a number of EU regional policies.

Aim

The 3rd module of the CSDP TLSC focuses on the idea and challenges related to the concept of EU strategic autonomy. This module will be the opportunity to further discuss and assess together the ability and the capacities of the EU on the strategic level.

The EU is indeed facing new, increasing and multidimensional threats and challenges. In order to counter, to protect EU citizens and to enhance its strategic autonomy, the EU needs to define what kind of global partner, in the field of defence and security, it wants to be. In this perspective, the EU is implementing various defence policies and concepts, notably PESCO and the EDF that require close cooperation between the EU institutions, EU Member States and industrial actors. It is thus important for the EU community to engage in a global debate as regards the concepts of strategic autonomy and European sovereignty, a necessary step in order to further develop a common strategic approach, through creating reinforced synergies between civilian and military representatives at the European level.
