<p><u>Target audience</u></p> <p>Participants should be members of the European Doctoral School on CSDP, PhD Fellows, invited researchers, and academics. Priority is given to EU Member States and Institutions.</p>	<p><u>Aim</u></p> <p>The ESDC Doctoral School Summer University aims to develop a critical mass of academic expertise that fosters collaboration between supervisors, mentors, and PhD researchers in European Security and Defence. It provides a platform for knowledge exchange, skills development, and academic research on the Common Security and Defence Policy (CSDP). <p style="text-align: center;"><u>Evaluation and verification of learning outcomes</u></p> <p>The course is evaluated according to the Kirkpatrick model: it makes use of level 1 evaluation (based on participant's satisfaction with the course) In order to complete the course, participants have to accomplish all learning objectives, which are evaluated based on the active contribution in the residential module, including their engagement in the practical activities and mentoring sessions as well as on their completion of the eLearning phases: course participants finalise the autonomous knowledge units (AKUs) and pass the tests (mandatory), scoring at least 80% in the incorporated out-test/quiz. Active observation by the course director/lead instructor and feedback questionnaire filled by course participants at the end of the course is used.</p> <p>The proposed ECTS are allocated based on the participants' workload and achievement of learning outcomes. This includes submitting a report on the state of their PhD research before the start of the activity. To attain the maximum 4 ECTS, PhD Fellows must prepare or present a recently written paper aligned with their research objectives, either for academic publication or policy-oriented applications.</p> <p>All CSDP Doctoral Fellows are required to reflect and bring on paper a structured reflection on their career stage, researcher profile strengths and challenges, career objectives, and specific needs they want addressed during the training event through discussions with mentors, lecturers, and EU staff.</p> <p>The Working Group of the European Doctoral School on the CSDP takes these factors into account when considering the awarding of certificates to participants. The Course Director is responsible for the overall coordination, with the support of the ESDC Secretariat, and drafts the final evaluation report, which is presented to the Working Group of the European Doctoral School on the CSDP and the Executive Academic Board.</p>
