### Invitation

It is our great pleasure to inform you that the **University for Continuing Education Krems** in cooperation with the **Austrian National Defence Academy** will conduct the pilot "*Cultural Property Protection Course*". The course takes place in residential form at the premises of the University for Continuing Education Krems, Dr.-Karl-Dorrek-Straße 30, 3500 Krems and the Benedictine Monastery Melk from 17 to 21 October 2022.

Since 2003, the European Union has been playing a crucial role in crisis management through its Common Security and Defence Policy. With about 30 missions and operations worldwide, the EU has proved its readiness to respond effectively and in timely fashion to emerging challenges.

Effective crisis management requires a combination of adequate capabilities and well-trained personnel. In response, one of the key tasks of the European Security and Defence College (ESDC) is to contribute towards human resources development and build a pool of knowledgeable crisis managers. The College provides basic to advanced courses ranging from orientation to specialized training for civil-military purposes specially designed to facilitate a comprehensive approach and to contribute to the establishment of a European Security Culture.

The "*Cultural Property Protection Course*" will set an awareness level on the necessity of protecting cultural property and heritage in EU's sphere of activity as well as picturise the scope of activities and efforts in the different fields of cultural property protection. Additionally, the course will provide the basis for an integrated and holistic approach regarding the protection of cultural property in crisis events based on good practices. During the course, participants will identify and analyse challenges for the protection of cultural property and provide tools to address them. With regard to an integrated and holistic approach, participants (civilian, military and police) are invited to create a network of people working in the field of cultural property protection.

We are pleased to invite you to this ESDC training activity, which is an excellent opportunity to gain a better understanding in the filed of *Cultural Property Protection*, to contribute to the further development of a European Security Culture as well as cooperation between the EU and non-EU partners.

### Krems & Melk Monastery, 17 – 21 October 2022 Administrative Remarks

(22-23/PILOT/6)

- Target group: The course is open to civilian, military and police personnel from EU Member States, relevant EU institutions and Agencies, CSDP Missions and Operations and International Organizations, UN/OSCE structures and Topic Related Training Institutions. Participants should working in conflict prevention, conflict management, post-conflict recovery and stabilization context who's responsibilities are linked to matters of cultural property and heritage protection on operative level in CSDP-missions.
- Nomination: All EU Member States, EU Institutions/ Agencies and International Organizations may nominate one (1) participant. As a result of national Covid-19 regulations, the total number of participations is limited to 40 persons.
- Application: Applications from the EU Member States, EU Institutions and Agencies are to be filed via the ESDC secure internet system ENLIST, by designated nominators, under <u>https://esdc.europa.eu/enlist/login</u>. A list with relevant ENLIST nominators can be retrieved from the ESDC website at <u>https://esdc.europa.eu/nominators/</u>.
- Registration & Deadline: The registration period will end on 9 September 2022. The
  registration will not be final until confirmed by the ESDC Secretariat <u>AND</u> upon completion of
  the ENLIST registration form by the nominated participant.
- Language: Working language is English without translation.
- **eLearning:** The course will be preceded by a mandatory e-Learning module, which needs to be finalised before the residential phase in Austria starts.

- Attendance: The participant's attendance during the course is mandatory on all days. A
  certificate will be awarded on the last day to those course participants, who have completed the
  full course, including the e-Learning modules.
- Course Venue: The course venue for the main part of the course will be at the premises of the University for Continuing Education Krems, Dr.-Karl-Dorrek-Straße 30, 3500 Krems. The final day will be hosted at the Benedictine Monastery in Melk, Abt-Berthold-Dietmayr-Straße 1, 3390 Melk. Transfer from Krems to Melk will be organized.



 Travel to Krems: Krems has a direct train connection to Vienna (Wien Heiligenstadt or Wien Spittelau are the most convenient subway stations for departing to Krems). The trains run every hour and it takes about one hour to reach Krems.

If you arrive by airplane, you catch the train to St. Pölten Hauptbahnhof (mainstation), where you change trains to Krems an der Donau.

• **Costs**: All costs for international travelling and accommodation (including breakfast) shall be covered by the sending authorities.

- Hotel reservations will need to be made individually, there are several hotels of different categories in the vicinity of the University for Continuing Education in Krems (enter the postal code "3500" or the address "Dr.-Karl-Dorrek-Straße Krems" into hotel search engines.
- Meals: All lunches will be provided as indicated in the programme for 60,- € / person. Money will be collected during the registration on Monday. On the first evening, there will be an ice breaker offered by the Austrian National Defence Academy. The Official Dinner on Thursday is upon invitation by the University for Continuing Education Krems.
- Dress code: Dress/jacket and tie or service uniform; for the Official Dinner "Smart Casual".
- Liabilities and Insurance: In case of medical emergencies, the costs should be covered by the participant's medical insurance provided by the sending country / organization. The organizers do not provide health or accident insurance for participants taking part in the event.
