



## Invitation to the ESDC Course: Mediation, Negotiation and Dialogue Skills for CSDP (Activity Number 23-24/28/2) Maynooth, Dublin, Ireland, 20 - 24/05/2024 Co-organised by Maynooth University and the European Security and Defence College (ESDC)

Maynooth University and the European Security and Defence College (ESDC) have the honour of jointly organising the course on Mediation, Negotiation and Dialogue Skills for CSDP from <u>20 May to 24 May 2024.</u>

The course aims to develop the participants' ability to negotiate and to use the mediation process in order to identify, prevent, manage and resolve conflicts. Relevant UN and EU mediation principles, such as inclusiveness and adherence to international norms (including prohibition of amnesty for serious war crimes), while remaining flexible and creative, will be taught and applied. These capacities are required at all stages of crisis management, whether when mission leaders meet with local stakeholders, or when EU police, military or civilian personnel, at isolated outposts, try to control an incident or arbitrate in a local dispute.

The focus of the residential week of this course will be on experiential learning. Individual competencies will be developed in a small team context, under the guidance of a tutor. The practical part of the course (simulation) provides an opportunity for the participants to apply and put into practice what they have learned and to relate it to a relevant international peacebuilding scenario.





The ESDC is committed to an inclusive, gender-sensitive and discrimination-free environment. Only in an inclusive environment can all people, and therefore the ESDC and its partners, realise their true potential. We therefore particularly encourage those applicants who are likely to be underrepresented to apply.

This approach means that participants will be introduced to some course content online and will then have the opportunity to work on and apply this content during the residential week. E-learning course content will be made available to participants on the university's online learning platform (Moodle) and must be completed prior to the residential part of the course. Participants are expected to bring their personal computers to class to facilitate their access to the online learning platform during the week.

The course is open to staff of the EEAS, public servants from EU Member States, justice, diplomatic, police and military establishments and third countries, or personnel who are deployed or are expected to be deployed in civilian and military crisis missions and operations.

We take great pleasure in inviting you to nominate participants, who will gain greatly from this course and acquire a sound understanding of this essential competency in crisis management.

#### 2. Administrative Instructions

- **Target audience:** the course is open to both civilian and military personnel from the EEAS, EU Member States, EU Institutions and Agencies, civilian and military CSDP missions and operations, candidate states, third countries and international organisations.
- **Fee:** the course has no tuition fee.
- Places and nominations: the total number of participants is limited to 27 (TBC). Typically, one place will be allocated to each Member State, but depending on the total number of requests, one additional place may be allocated.
- Applications: applications from EU Member States and EU institutions and agencies must be submitted via the ESDC secure internet system ENLIST, by designated nominators no later than **18 April 2024**. A list of relevant ENLIST nominators can be found on the ESDC website at https://esdc.europa.eu/nominators/.

Applications from third countries should be sent to <u>enver-</u> <u>ferhatovic@eeas.europa</u> indicating:

- - full name of the candidate
- - personal e-mail address (functional mailboxes will not be accepted)
- - institution
- - reason why this course would be of benefit to the applicant
- **Registration** will not be final until it has been confirmed by the ESDC Secretariat and the participants have provided the requested data on ENLIST.
- **The language** used in the course will be English.
- Course content: Participants will also bring their personal computers to class to facilitate their access to the online learning platform during the week.





- Attendance participants' attendance is mandatory every day of the course. Participants will receive an ESDC certificate on the last day only if they have completed the whole course, including the e-learning modules.
- Residential part of the course: the course venue for the week will be <u>Maynooth University</u> <sup>1</sup> from 20 to 24 May 2024 (Monday 14:00 to Friday 13:00).
- **E-Learning**: the course will be preceded by mandatory e-learning autonomous knowledge units (AKUs), which will be available from 22 April 2024 on the ESDC e-learning platform ILIAS. Course participants will have to complete the Autonomous Knowledge Units (AKUs) before the residential phase of the course begins (Monday 20 May 2024).
- **Costs**: sending authorities will cover all travel, accommodation and catering (including breakfast) costs incurred during the residential part.
- **Dress code**: the dress code is 'daily office uniform' for military personnel and 'business casual' (e.g. jacket with tie for men) for civilian personnel.
- Liabilities and insurance: in the event of a medical emergency, participants' medical insurance provided by the sending country/organisation will cover all costs. The organiser will not provide health or accident insurance for course participants.

Please do not book flights or accommodation before receiving confirmation of attendance.

- A reception will be held on campus on Monday evening (20 May). There will also be a course dinner on Thursday (23 May).
