17th ESDC Course on the Comprehensive Protection of Civilians (also UN-certified)

14 - 18 NOVEMBER 2022

Course Description

The UN Security Council Resolution 1894 calls upon the international community and conflict parties to implement far-reaching measures to protect and support civilian populations in situations of armed conflict. The content of this training course reflects a broad interpretation of



from physical violence, but also includes the creation of larger protective environments and the implementation of activities that enhance the rights of individuals in accordance with international humanitarian law, human rights and refugee law.

protection, which goes beyond the provision of protection

The five-day training course prepares senior decision-makers of armed forces, police, political bodies and non-governmental organizations, as well as individual civilian experts involved in peacekeeping and/or international

crisis management at the operational level for the challenges in protecting civilian populations in contexts of armed conflict or post-conflict situations.

Graduates of this course will be provided with a comprehensive understanding of the multiple dimensions and meanings of the protection of civilians. They will have enhanced knowledge of the actors and their roles and responsibilities in the subject matter and will be in a position to identify options for coordination and synergies in the implementation of protection for civilians. They will be able to analyze the specific threats to and the needs and rights of different vulnerable groups of civilians affected by armed conflict to develop and implement context-sensitive, comprehensive, integrated strategies and measures to improve situation of civilians in armed conflict.

The course was developed in close cooperation between the Federal Ministry of Defence and the Austrian Study Centre for Peace and Conflict Resolution and has furthermore been supported by the Federal Chancellery of the Republic of Austria, the Federal Ministry of Europe, Integration and Foreign Affairs and the Federal Ministry of Interior. It confirms Austria's continuous effort to promote the protection of civilians in armed conflict. Since 2014, the training is part of the framework of the Academic Programme of the European Security and Defence College (ESDC) and has furthermore been certified by the Integrated Training Service of the United Nations Department for Peace Operations.

The course takes place from 14 – 18 November 2022 and will be conducted at the premises of the castle of Schlaining in Stadtschlaining, Austria. I. It will be hosted by the Austrian Federal Ministry of Defence and be implemented by the Austrian Study Centre for Peace and Conflict Resolution (ASPR).

Requirements for Participation

The course targets national and international experts and senior decision-makers of armed forces (from rank of Major/OF-3 and above), police (equivalent senior police officers and above), non-governmental/civilian organizations (heads of substantive sections and above), and political/civilian administration (heads of division/department and above) working with or in the context of peacekeeping operations in complex emergencies requiring the protection of civilians in armed conflict.

Application Procedure

Qualified candidates matching the set participants profile as outlined above are requested to fill the online application form and submit it strictly by the <u>deadline of 25 September 2022.</u>

The designated Course Admission Board will select the course participants from the timely submitted applications while balancing affiliation, professional background, gender, nationality and working contexts in view to keep the intended course quality and standard.

Applicants are thereafter informed about the decision of the Course Admission Board within 2 weeks after the set application deadline.

Additional Information - Course on CPOC

1. Conditions of Participation

a. Expected Participant's Profile

This course is set at the operational level and targets national and international mid- to senior level experts and decision-makers of armed forces (from rank of Major/OF-3 and above), police (equivalent levels of senior police officers), United Nations Missions and Agencies, International and Regional Organisations and staff from non-governmental/civilian organisations (UN professional level P3 and above or equivalent in other organisations, head of substantive section and above), and the political/civilian administration (senior staff, head of division/department and above) who are working in the context of or with peacekeeping operations in complex emergencies requiring the protection of civilians in armed conflict.

The course is a specialisation course and participants are expected to bring basic knowledge of and/or experience of work in peace support operations, kindly note that it explicitly is <u>not an induction course</u>.

It is furthermore <u>not open for academic researchers or university students</u>, but reserved for practitioners and experts only, as explained above.

b. Expected Preparations

Participants are required to complete <u>selected e-Learning modules</u> in the preparatory phase preceding the residential part of this course. The timely completion of these eLearning modules is a precondition for participation and for receiving the course certificate.

Participants are expected to be available over email as soon as they have been confirmed for participation by the ASPR and keep ongoing contact with the ASPR for all preparation steps.

c. Course Language & Expected Attendance

The course language is English, and <u>participants must be fully proficient in English</u> to be able to engage in discussions and fully benefit from the training.

Course participants must be present at the course and fully participate to all course elements, as per the programme. Participants are to be released from any other duties during the course time to allow the necessary learning in a very intense and fully packed week. Absence during the course may result in disqualification from the course diploma.

d. Certificate

Successful participants are rewarded with an official ESDC certificate at the end of the course residential phase. The certificate will only be granted if the pre-residential e-learning and the residential phase have both been completed successfully.



2. Selection Criteria

From all timely submitted applications, a Course Admission Board, consisting of subject matter experts, strives to select a highly qualified group of participants to ensure the set course standard. The selection process considers a balance in professional and organisational backgrounds, age, nationality and gender.

Qualified female candidates are strongly encouraged to apply!

Since the slots are limited to 30 participants, only the best qualified candidates can be admitted. The selection of the Course sAdmission Board is final and cannot be challenged.

Depending on applicable national SARS COV II regulations, selection and admission may also be subject to the travel and immigration regulations accordingly (see specific point below).

3. Course Cost

The ESDC Courses are a capacity building measure by EU member states for their personnel working in or being deployed to CSDP missions. According to the agreement by the EU member states, the following cost sharing arrangement has been decided: The country where the ESDC course takes place is the course host and covers all general course-related issues while the sending member states cover the cost for the individual participants they send (see details below).

To be covered by participants:

a. Travel and Full Board Accommodation

Participants are to organise and book their travel to the course premises to arrive at the accommodation on Sunday, 13 November 2022. Note: individually organized transportation to the town of Stadtschlaining from the Vienna International Airport ranges anywhere between 100 EUR for pre-booked taxis to 200 EUR when booked upon arrival (careful, very limited availability of private and public transport to Stadtschlaining!).

More detailed guidance on available ground transport options will be provided to the confirmed participants.

Any costs for immigration to Austria are to be covered by the participants, this also includes visa fees, costs for required tests and vaccinations for SARS COV II.

Participants are to organise and book their own accommodation. The course premises of the ASPR are located directly across from the "Hotel Burg Schlaining", where accommodation and meals can be booked by the selected participants, once their participation has been officially confirmed by the ASPR. Depending on the room category, prices for the overnight with breakfast at the "Hotel Burg Schlaining" range from 95 to 120 EUR; meals are 25 EUR excluding drinks. Prices may be subject to change as per the hotel's policy.

Any extra costs incurring during the course (laundry, phone etc.) are to be covered by the participants.



<u>Detailed joining instructions will be issued to confirmed participants only. Applicants/sending entities are kindly requested to commence bookings only when the official confirmation of participation has been received.</u>

b. Conference Costs & Hosted Dinner

Costs for Expert Trainers, course materials, the conference facility and 2 coffee breaks per course day are covered by the Federal Ministry of Defence of the Republic of Austria.

4. Health Insurance and SARS COV II

Note: These are the regulations known at the time of the announcement of the course; they may change according to official regulations.

Participants are to be fully covered by a valid health insurance; the ASPR and the course host do not cover any medical costs, including emergencies and costs for the treatment of SARS COV II infections.

All official regulations of the Republic of Austria for SARS COV II must be observed for immigration and the duration of the stay and are the responsibility of the participant.

It is anticipated that for the course participation, participants will most likely need a valid EU-approved and completed vaccination and will have to bring the relevant international certificates accordingly.

Participants must bring their own FFP-2 masks and wear them as per the regulations.

Relevant safety measures will be set up for the running of the course in order to guarantee maximum protection for all participants and persons tasked with the course implementation.
