## Invitation to the Pilot Seminar on The Legal Framework of Defence-Related EU Policy-Making

The Directorate-General for Legal Affairs of The German Federal Ministry of Defence, the European Security and Defence College and the Helmut Schmidt University of the German Armed Forces have the pleasure of hosting a Pilot Seminar on The Legal Framework of Defence-Related EU Policy-Making to be held in Hamburg from 14 to 17 November 2023.

European initiatives regarding defence and military matters have been surging in recent years. As envisaged by the Lisbon Treaty, the European Union (EU) has made significant steps towards the progressive framing of a Common Union Defence Policy. These developments were accompanied by crucial legislative and law-making initiatives across the entire range of EU policy areas that directly and indirectly concern the armed forces. Most notably, a number of key supranational regulatory packages adopted by the EU have a significant impact on defence. In addition, the 2022 Strategic Compass contains policy guidance concerning important CSDP legal bases. A thorough understanding of this legal background is vital for strengthening defence co-operation, timely decision-making at EU and national level, and the application and implementation of EU law in the Member States.

Against this backdrop, the interactive seminar aims to promote a comprehensive understanding of the legal foundations underpinning the CSDP as well as supranational EU initiatives. It will provide a broad overview of relevant EU law, highlighting crosscutting issues relevant to participants' day-to-day work.

- Target Audience: The seminar is open to both civilian and military personnel from EU Member States and EU institutions/agencies/bodies. EU Member States and EU institutions/agencies/bodies are invited to nominate one or two participant/s each.
- Preferably, nominees should have a background in law (ideally a graduate degree)
  and basic knowledge of EU law. A limited number of places will be offered to
  participants from other areas of expertise.
- Format: The seminar consists of an *e-Learning and a residential part*, held in Hamburg from 14 to 17 November 2023; *both parts are compulsory*. Attendance of the seminar is mandatory on all days. A certificate will be awarded to those participants who have completed the full seminar, including the e-Learning modules.
- **Time:** The seminar starts at 09.00 on 14 November and ends at 12.30 on 17 November 2023.
- Language: The working language is English. No translations will be provided.
- **Cost:** Costs for traveling, accommodation and catering (except for the official dinner and the reception) will be covered by sending authorities.
