











## Invitation to the

## CYBERSECURITY RISK MANAGEMENT

(ESDC Activity Number 24-25/205/1)

## Budapest, Hungary, 14-17 October 2024

Under the auspices of the European Security and Defence College (ESDC), the Hungarian Ludovika University of Public Service (LUPS), the Military Academy 'General Mihailo Apostolski' (MAGMA), and the University of Montenegro (UCG), in cooperation with the European Union Agency for Cybersecurity (ENISA), have the honour of organising a training activity on Cybersecurity Risk Management, which will run from Monday 14 to Thursday 17 October 2024, in Budapest, Hungary.

Aligned with ESDC's Cyber ETEE platform, this course is specifically tailored for public sector employees from EU Member States, EU institutions, bodies, and agencies, and is also open to public-sector employees from EU candidate countries who are responsible for roles in cybersecurity risk management. The course supports the European Cybersecurity Skills Framework (ECSF), specifically ECSF Role 10: Cybersecurity Risk Manager.

The overall aim of the Risk Management course is to build skills and abilities for the identification, analysis, assessment, and mitigation of cybersecurity-related risks in ICT infrastructures, systems, and services. Participants will learn to plan, apply, report, and communicate risk analysis, assessment, and treatment.

The objectives include: providing participants with significant knowledge in implementing an Information Security Management System (ISMS); reinforcing technical knowledge in cybersecurity through the identification and implementation of technical controls; improving skills in managing a risk assessment programme; identifying measures necessary to protect information and ICT systems; and providing guidelines and best practices for managing information security policies, analysing critical assets, and identifying threats and vulnerabilities.

The course is structured into two parts: an asynchronous eLearning component introducing Information Security and Risk Management, and a classroom course running from 14 to 17 October 2024, focusing on implementing Information Security Management and applying controls to minimise risks.

On completion of the course, participants will be able to participate in risk management tasks, effectively address security risks, and develop and implement information security policies. They will also have the capability to establish action plans for securing information systems within their organisations.
