This basic course is a major component of the EU educational and training programme, and as such has been included in the ESDC training programme for 2023. It aims to provide participants with a broader understanding of the SSR concept and increase their awareness of challenges and developments in the field.

Only in an inclusive environment can all people, and therefore the ESDC and its partners, reach their true potential. We therefore particularly encourage applicants who are likely to be under-represented to apply.

#### **ADMINISTRATIVE INFORMATION**

### ESDC Basic Course on Security Sector Reform Bucharest, 23-25 October 2023

(Training activity number 23-24/10/2)

- Target group: The course is open to both civilians, including diplomatic personnel, and police and military personnel from EU Member States, relevant EU institutions and agencies, Common Security and Defence Policy (CSDP) missions and operations, and international organisations. The course is also open to non-EU countries and Eastern Partnership countries.
- Places & nominations: A maximum of 50 places will be available for participants from EU countries and non-EU countries (20 of which from Eastern Partnership countries). Typically one place is allocated per EU Member State. However, depending on the total number of requests, one additional seat could be provided. We are seeking a balanced group composed of civilians and police and military personnel.
- How to apply: <u>Designated nominators</u> should use the ESDC secure internet system <u>ENLIST</u> to submit applications from EU Member States, EU institutions and agencies no later than 29 September 2023. Registration will only be complete once the ESDC Secretariat has sent a confirmation AND the nominated participants have completed the registration form.
- All applications from non-EU countries and Eastern Partnership countries (up to four participants each, preferably representatives of ministries of internal affairs, defence or foreign affairs, with priority being given to experts from law enforcement and diplomats with responsibility for the CSDP/CFSP), should be sent to Enver Ferhatovic, the Training Manager, indicating the applicant's full name, position, institution, personal email address and phone number, no later than 29 September 2023.
- Attendance: Participants must attend the course on all days. A certificate will be awarded on the last day to those who have completed the full course, including the e-Learning modules. This course will not be offered in a hybrid format.
- <u>The course will begin on 2 October 2023 with the e-Learning module</u>. All essential Autonomous Knowledge Units must be completed before the residential module begins. The residential part will be held in <u>Bucharest from 23-25 October 2023</u> (10.00 on Monday to 13.00 on Wednesday). The tentative schedule is attached; an updated programme will be distributed before the course begins.
- Once the list of participants has been finalised, the designated course director / contact person will get in touch with the participants by email.
- Language: The working language is English (no interpreting available).







#### **Costs**:

- The sending country/authority/organisation of participants from EU Member States, EU institutions and CSDP missions/operations, or from international organisations and non-EU countries other than Eastern Partnership countries, must cover all related costs (travel, accommodation and catering/meals; NO course fee payable).
- The course will receive support from the **Eastern Partnership** managed by the European Commission. As a result, all costs relating to participation by Eastern Partnership beneficiaries will be covered by the Commission. As soon as the organisers have received nominations, a selection board will accept and confirm participants. The Commission will then contact the participants to arrange flights and accommodation. Please ensure that each candidate has a valid personal email address.

#### **Details:**

- The course will be held at the <u>Sheraton Bucharest Hotel</u>, Calea Dorobantilor 5-7, Bucharest 010551, Romania.
- The programme, workshops, speakers etc. will be made available in the practical information provided after the selection process has been completed.
- **Dress code**: Formal or service uniform for opening and closing ceremony; smart casual for the working sessions.
- **Liabilities and insurance**: The participant's medical insurance provided by the sending country/authority/organisation must cover all costs in the event of a medical emergency. The course organiser does not provide personal health or accident insurance for this course.

  due course, including information directly linked to any travel restrictions or the health
  situation in Romania/the EU.
