# FOREIGN INFORMATION MANIPULATION AND INTERFERENCE (FIMI) COURSE

### Activity no. 23-24/PILOT/9

The European Security and Defence College, in partnership with 'Mihai Viteazul' National Intelligence Academy, has the honour to organise and to invite participants to the first edition of the course entitled **Foreign Information Manipulation and Interference (FIMI)**. The course will take place from 5 to 8 December 2023, in residential format, in Brussels.

The course will approach issues regarding the EU strategic environment; the multilayered threats against the EU; emerging technologies employed in information warfare; the EU integrated approach to situational awareness; resilience, response and cooperation against FIMI; key FIMI actors and priority regions and an analysis of the practitioners' toolkit to managing the information security ecosystem. Furthermore, it will feature practical sessions designed to develop the participants' abilities to detect and appropriately respond to FIMI events.

The final goal of this FIMI course is to foster and develop an understanding of FIMI framework, modus operandi and appropriate response measures so as to assist in developing societal resilience to such actions and to help to consolidate European democracies.

The ESDC is committed to an inclusive, gender-sensitive and anti-discriminatory environment. # **Administrative Information**

#### 05-08.12.2023-23-24/PILOT/9

- **Target group:** representatives (civilian, diplomatic, police, military) from EU Member States as well as institutions, agencies, missions and operations.
- Places and nominations: one seat per Member State will be available, together with up to ten seats for staff from EU institutions (one per entity) and five seats for personnel from EU Missions. Due to course specifics and format of practical exercises, no additional seats can be allocated.
- Applications: are to be submitted via national ESDC nominators (<u>https://esdc.europa.eu/nominators/</u>), no later than **10 November 2023**;
- Attendance: participants' attendance on all days of the course is **mandatory**. A certificate will be awarded on the last day to those course participants who have completed the entire course. This course will not be offered in a hybrid format.
- Language: the working language is English, without interpretation.
- **Costs:** participants or their respective sending institution will bear the costs related to their participation.
- Inclusive environment: the ESDC strives for a gender-sensitive and inclusive environment in all its courses, activities and day-to-day work. Only in an inclusive environment can all people, and therefore the ESDC and its partners, reach their true potential.
